Dear Parents and Guardians,

As we prepare for the 2025-26 school year, the Fallbrook Elementary School District is working towards providing transportation services. The transportation department will be accepting bus pass applications for the next school year. We are asking all new and returning students to complete a Bus Pass Application and return in by May 29, 2025.

The District plans to offer transportation services for students residing beyond a 1-1/2 mile radius from home residence to school site. Eligibility is determined based on the student's home address. There is no fee for transportation services. Eligible bus riders will receive a bus pass prior to the start of the school year on August 11, 2025. Bus passes will be mailed to the student's home address, along with the bus Transportation Safety Rules, a diagram of the school bus loading and unloading danger zones, and a School Bus Safety Supplement. We ask parents and students to familiarize themselves with this information. If you do not receive your child's bus pass by July 25, 2025, please contact the Transportation Department. Special education students who require transportation per their individualized Education Plan (IEP) are exempt from this process.

The safety of our students and staff remains our top priority. The Transportation Department will continue its operations in compliance with California Department of Public Health (CDPH) guidelines. Our protocols for school bus transportation may change if we receive updated guidance from CDPH. Thank you for your patience. We look forward to safely transporting our students! Estimados Padres y Tutores:

Mientras nos preparamos para el año escolar 2025-26, el Distrito Escolar de Fallbrook Union esta trabajando para proveer servicios de transporte. El Departamento de Transporte estara aceptando solicitudes de pase de autobus para el proximo año escolar. Estamos pidiendo a todos las estudiantes nuevos y que regresen a llenar una Solicitud de Pase de Autobus y la devuelvan antes del 29 de mayo de 2025.

El Distrito ofrece servicios de transporte para las estudiantes que residen mas alla de milla-y-media a la redonda (radio) de su residencia a su sitio de escuela. Elegibilidad se determina segun el domicilio del estudiante. No hay ninguna cuota para las servicios de transporte. Los estudiantes elegibles recibirán un pase de autobus antes del inicio del año escolar el 11 de agosto de 2025. Pases de autobus serán enviados a la direccion listada en el sitio de la escuela, junta con las reglas de seguridad del autobus, un diagrama del autobus escolar indicando las zonas de peligro de carga y descarga, y el Suplemento de Seguridad de Autobus Escolar. Los padres y las estudiantes deben familiarizarse con las reglas de seguridad en un esfuerzo para mantenerse informado y asegurar un viaje seguro. Si no recibe el pase de autobus para su estudiante antes del 25 de julio de 2025, póngase en contacto con nuestro departamento. Estudiantes de educación especial que requieren transporte segun su Plan Individualizado de Educación (IEP) estan exentos de este proceso.

La seguridad de nuestros estudiantes y personal sigue siendo nuestra prioridad. El Departamento de Transporte continuara sus operaciones de conformidad con las directrices del Departamento de Salud Publica de California (CDPH). Nuestros protocolos para el transporte en autobus escolar pueden cambiar a medida que recibimos orientación actualizada del CDPH. Gracias por su paciencia mientras navegamos estos tiempos sin precedentes. Esperamos transportar a nuestros estudiantes de forma segura!
